**Contract:** This contract is a binding document for the dates indicated above. Families will be responsible to pay for their scheduled contract days, whether child is present or not for the entire contracted period.

**Fees:** Tuition payments are due for the current week of service on the first contract day of each week. If families choose to pay bi-weekly or monthly, in advance, these payments will be credited to their accounts. A ledger statement of each family's account will be distributed monthly by the office.

**Registration Fee:** \$100.00 per family is due upon registration. This is a non-refundable registration fee. \$100.00 is due each year upon the anniversary of the initial enrollment date. The annual fee (not the initial non-refundable registration fee) will be waived upon completion of eight hours of documented participation in Center fundraising activities prior to the anniversary date. Those families choosing not to participate in fundraising activities will be required to pay the annual \$100.00 fee.

**VIP Days:** VIP (vacation/illness/personal) days will be granted for the summer contract period. Days earned depend on the contract period and the number of days per week of Camp Cool contracted attendance. (Please see Parent Handbook for specifics.) VIP days are not cumulative and family must notify the Center in advance to use a VIP day for an absence.

**Fees:** The current rate schedule is attached to this contract. Applications for scholarship must be submitted with each new contrac.

Northern Door Children's Center carries liability insurance that meets and exceeds the limits as required by Wisconsin Administrative Code. Parents/Guardians bear the responsibility for any additional student insurance.
